together with all income interest, rent, dividends etc. henceforth to due on the said sum or accretions there to or investments for the time being representing same are the brevity's sake called collectively (the said "Trust Fund") upon Trustee's and subject to the power, provisions, agreements and declarations hereinafter declared and contained of and concerning the same.

**NAME OF THE TRUST shall be :**

**Manav Sthal Global Foundation Trust**

**By aforesaid Trustees :** The Trust is established and managed by Members of the Trust and engaged in carrying out public charitable objects and purposes wide enough for the extension of the benefit thereof to all, irrespective of class, community, creed and relief of poor, education (Higher Technical, Medical, Management, Schooling education), medical relief and advancement of any object of general and/or public utility and so that such benefit may given directly by the said Trust. The basic aim of the Trust would be to promote welfare and educational development of the youth and poor.

**PRINCIPAL OFFICE AND JURISDICTION:**

The office of the Trust will be located at **166, Shivalik Enclave, Race Course, Dehradun 248001 (Uttarakhand)**, if felt necessary, the Trust can open offices at other places also - jurisdiction of the Trust shall be India, Asia but can extend outside in i.e. abroad in other Countries also.

**PROPERTY OF TRUST :**

Each Trustee has to donate **Rs.2100/- minimum** as a Trust Fund for proper functioning of the Trust. This amount will be considered as property of Trust which would be minimum **Rs.11,000/-** -at present. The Founder Trustees of above mentioned Trust have decided that all the activities, Projects shall be run under the guidance of Trustees and under the Policy laid out by the Founder Trustees. The movable and immovable property of the Trust will belong to Trust and for this reason **Manav Sthal Global Foundation Trust** is being registered. In future any land

property, cash, ornaments, movable and immovable property which is received from any person any Institute or any other Trust in shape of donation or grant from India or abroad shall belong to the aforesaid Trust.

**AND IT IS HERE BY AGREED AND DECLARED THAT OBJECTS AND OBJECTIVES & PURPOSES OF THE TRUST SHALL BE :**

The Trust is established and managed by Members of the Trust and engaged in carrying out public charitable objects and purposes wide enough for the extension of the benefit thereof to all, irrespective of class, community, creed, religion, belief and relief of poor, education (Higher Technical, Medical, Management, Schooling education etc), medical relief and advancement of any object of general and/or public utility and so that such benefit may given directly by the said Trust. The basic aim of the Trust would be to promote welfare, health, employment and educational development of the aged, women, underprivileged/handicapped children, youth and poor etc.

1. To Establish spiritual university & city and to preach Vedas, Upanishads, astrology, music and other metaphysical subjects, Drama, non-violence and universal brotherhood by conducting Satsang, Sadhana, Tapasya with establishment of places of worship etc. To acquire, lease, buy, land & buildings with donation /Gifts to achieve the objectives of Trust.
2. To conduct education in spiritual health or provide assistance in the provision of spiritual health care education to the mass, to overcome mental pollution.
3. To open and run Technical Education Colleges i.e. Engineering/Polytechnic/ vocational Schools/ Colleges etc.
4. To open and run Medical/Para medical/Dental/Nursing/Pharmacological Colleges.
5. To run Public Welfare Schemes which are sponsored and run by Govt. with the help of own/self or other Institutes for good & welfare of Society.
6. To pioneer/open and property run, the Allopathic Hospitals, Dispensaries, libraries, Reading rooms, recreation and cultural Centers and community centers.
7. Engineering, Medical, Information-technology, Business, Management, Architecture, Masscommunication, Fashion, Design, Hospitality, Media

8. To open, run Homeopathic, Ayurvedic, Siddha, Acupressure, Acupuncture, neurotherapy, Natural Sciences Hospitals/ Medical Colleges for the education and purpose with OPD's and to conduct research in this field.
  9. For the aforesaid purposes to fund, maintain, organize, run, manage, supervise, superintend, co-ordinate, affiliate, control, guide, and aid Pathshalas, Schools, Colleges, Institutions, Universities, Libraries, Auditoriums and Lecture Halls etc.
  10. To set up hospitals/nursing homes for poor citizen with special attention to women, children, aged, physically & mentally challenged etc.
  11. To publish and distribute text and note books, study materials to persons interested in studying Bhagavad-Gita, Vedas, Upanishads, Sahita's, Purana's and philosophy of other schools of thought;
  12. To establish & create, spiritual malls, floating Ashram, institutions of special learning, human force with zero tolerance to nature's destruction.
  13. To open i.e. to establish and run Dental Education College and Dental Hospital and Research Center.
  14. To open and run Medical Education Colleges, Hospitals and Research Centers and specialized Hospital Units in the other cities and under aegis of Medical Colleges.
  15. To open Public Schools for International education upto 'O', 'A' and 10+2 level and also to open degree and Post Graduate Colleges/Universities.
  16. To run Old Age Homes, Prayer Homes, meditations Centers, Yoga Kendra's and to maintain and run it properly anywhere in India & abroad.
  17. To open Public Schools on Gurukul Traditions.
  18. To run Old Age Homes, and to run it properly anywhere in India.
  19. The trust will be free to perform all work which is helpful for social upliftment of the Society and the Progress of the Country.
  20. To help / provide aid to talented players in sports.
  21. To run and help the Institutes and organizations which are working for the similar objectives.
  22. To establish and run Ayurvedic Colleges, Training Centers and Hospital,

dispensaries and Ayurveda Medicine production units, Protection of Cows, creating Goa-shalas & dairies.

23. To grant scholarship for higher Education to the needy, poor and deserving candidates, stipends, prizes and grants of other kinds, of financial aid or supply books, stationary, clothing and any other materials for advancement of education in any field to needy and deserving students in India or Abroad and to give loans to deserving students for studies in India or abroad on suitable terms and conditions.
24. To Promote balanced rural development by implementing such Schemes or programmes either individually or with the help of other institutions, organizations, Govt. and semi Govt. Departments which may benefit rural inhabitants of India.
25. To engage in the activity of publishing of news- papers, Journals, periodicals to support and benefit writers, poets, correspondents, Editors, Compositors, Pressmen reporters, Authors and other persons engaged therein.
26. To own, establish or /and maintain printing presses/Electronic Digital channels for printing News Papers, Periodicals, Books, Telecasting etc.
27. To promote, charitable, cultural, spiritual Educational and any other activity for the relief of poor and the education of the needy and to afford medical relief to the poor and /or prompt any other object of public utility without distinction of caste, creed, religion, and race within the Union of India.
28. To establish, start, run or to maintain Charitable Dispensaries, Hospitals, Girls and Boys Schools and Medical Colleges, Dental Colleges, Engineering Colleges, Nursing Colleges, Libraries, Reading Rooms, Recreational and Culture Centers, Community Centers, Sports and Debating Clubs, Boarding Houses or Hostels for poor, needy, distributes, invalid Blinds etc. and financial assistance Research Institutions etc.
29. To give financial help either in cash or kind to widows, orphans, invalids and needy persons.
30. 26. To support provide financial or monetary assistance or help or to pay any sum of money in the form of donations, subscriptions, contribution, monetary aids and / or financial assistance to any society, organization, institution, club, seva samiti, society, or any person or persons or associations of persons interested in, or running dispensary, hospital, dawakhana, sanatorium,

- school, colleges, research centers, library, reading rooms, recreational and cultural centers, community centers, sports and debating clubs, Yoga ashrams, Sanskrit Schools, Vedic Schools, training Centers for priests, Boarding Houses or Hostels for Poor, Needy, invalids, destitute, blinds or engaged in providing other public utility services.
31. And generally to do all other acts, deeds and things as may be conducive to the attainment and furtherance of any or all of the other objectives and purposes of the Trust and/ or in any other way similar to them.
  32. The Managing Trustee/President or the Board of Trustees duly authorized by the Chairman shall have the power to set up one or more Managing Committees from amongst themselves or from general public for the routine day to day management and working of such institution and control. The Managing Trustee/President of the Board of Trustees shall be entitled to frame the constitution and regulate the proceedings of such committees and to delegate to them any such powers as the Chairman or Board of Trustees shall consider necessary.
  33. To appoint advisory committees to help the trustees in the management of the affairs of the trust or any institution maintained or run by it and discharge of them duties on such terms and conditions as they may determine.
  34. To train youth in human values and to build a humanity home.
  35. To start training institutions or centers to promote Yog, Dhayana (Meditation), Kaya-kalpa (Science of Rejuvenation) with Samadhi- Yog (Science of Realization).
  36. To make donations to other public charitable Trusts/institutions recognized under Sec. 80-G of the Income Tax Act, 1961. To get donations under sec-80G, 12A, 35(1)(11) etc of Income tax Act, 1961 & apply for same.
  37. To provide social security and economic security for all irrespective of class, community and creed.
  38. To impart, promote and spread education in arts, literature, science and commerce, philosophy and in such other subjects as the Board of Trustees may decide from time to time.
  39. To render financial assistance to the poor and the disadvantaged.
  40. To promote and advance moral education, charity and general welfare of the people.
